NORTH GEORGIA CREDIT UNION'S RABUN COUNTY STICKER CONTEST OFFICIAL RULES

1. ELIGIBILITY

- The contest is open to all residents of or those who work in Rabun County, Georgia.
- Employees of North Georgia Credit Union and their immediate family members are not eligible to participate.

2. CONTEST PERIOD

- The contest will run from Wednesday, October 25th, 2023 to Wednesday, January 31st, 2024.

3. STICKER DISPLAY

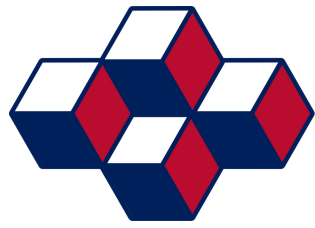
- Participants must display the North Georgia Credit Union stickers on their vehicles to be eligible for consideration.
- Stickers must be displayed prominently and clearly visible by North Georgia Credit Union staff.

4. RANDOM CHECKS

- North Georgia Credit Union staff members will conduct random checks during the contest period.
- Checks will be performed on various days, at various times, and at various locations within Rabun County, Georgia to ensure fairness.
- The decision of North Georgia Credit Union staff on whether a sticker is displayed correctly and qualifies for a reward is final.

5. VOUCHER DISTRIBUTION

- Vouchers for a gift card will be awarded at the discretion of North Georgia Credit Union staff during the random checks.
- There is a limited supply of forty vouchers: ten vouchers for Clayton Cafe, ten vouchers for Reeves, ten vouchers for The Rusty Bike Cafe, and ten vouchers for White Birch Provisions.
- The type of voucher will be distributed at random.
- The vouchers will be distributed on a first-come, first-served basis.
- Each eligible vehicle may receive only one voucher during the contest period.

6. REDEMPTION

- To redeem a voucher for a gift card, participants must visit North Georgia Credit Union's Clayton branch located at 579 Highway 441 South, Clayton, Georgia 30525 before the expiry date of Friday, February 16th, 2024.
- Participants must present the issued voucher, which will include the vehicle's tag number.

7. DOCUMENTATION

- North Georgia Credit Union staff will document the tag number and employee name on the voucher for verification purposes.
- A copy of the documentation will be kept as a record and disposed of after the event on Monday, February 19th, 2024.

8. PUBLIC ANNOUNCEMENT

- North Georgia Credit Union may announce the names and, if consent is provided at the time of reward redemption, share photos of selected participants who have received their gift cards.
- Participants will be given the opportunity to sign a photo release form at the time of receiving their reward to grant or deny permission for the use of their name and photo for promotional purposes.

9. LIMITATION

- North Georgia Credit Union reserves the right to modify or terminate the contest at any time.

10. COMPLIANCE

- All participants must comply with local and state laws regarding vehicle displays and safety.

11. PHOTOGRAPHY AND PRIVACY

- For security and privacy reasons, North Georgia Credit Union employees are prohibited from taking pictures of participants' vehicle license plates during the contest. We respect the privacy and safety of our community members.
