

# NORTH GEORGIA CREDIT UNION'S SUNNY'S SAVE-A-THON CONTEST OFFICIAL RULES

#### 1. ELIGIBILITY

- The Sunny's Save-a-Thon Contest is free and open to all youth under 18 whose parent/guardian completes and returns a Sunny's Save-a-Thon Registration Slip to a North Georgia Credit Union (NGCU) location during the month of April 2024, from Monday, April 1, 2024, to Tuesday, April 30, 2024.
- While we encourage youth to make a deposit while visiting our branch locations, no deposit is required to enter the contest.
- Youth do not need to be a member to participate in the Sunny's Save-a-Thon Contest.
- Employees of North Georgia Credit Union and their immediate family members are not eligible to participate.
- Definitions:
  - Youth: Any person under the age of 18.
  - Parent/Guardian: A legal guardian or a biological or adoptive parent who has legal responsibility for the youth participating in the contest. This includes individuals who have been granted legal guardianship or custodial rights by a court of law.
  - Immediate Family Members: An immediate family member includes a person's parents, siblings, spouse, children, or those who live in the same household.

# 2. CONTEST PERIOD

• The contest will run from Monday, April 1, 2024, to Tuesday, April 30, 2024.

#### 3. SUNNY'S SAVE-A-THON REGISTRATION SLIP

- Parents/guardians must permit for their child to participate by filling out the Sunny's Save-a-Thon Registration Slip and returning it to NGCU.
- All Sunny's Save-a-Thon Registration Slips must be received before 5:00 PM Eastern Time (ET) on Tuesday, April 30, 2024.
- Limit one entry per person.
- The odds of winning will depend on the number of entries received.
- This contest is void where prohibited.



#### 4. METHODS OF ENTRY

- Participants can visit NGCU branch locations, mail their completed Sunny's Save-a-Thon Registration Slip, or deposit their completed Sunny's Save-a-Thon Registration Slip in a night depository at one of NGCU's branch locations.
- Current Savasaurus Club members of NGCU will receive a Sunny's Save-a-Thon Registration Slip and Sunny's Save-a-Thon Contest information by mail.
- Regardless of the method of entry, all Sunny's Save-a-Thon Registration Slips must be received by 5:00 PM Eastern Time (ET) on Tuesday, April 30, 2024.
- Incomplete or inaccurate information listed on the Sunny's Save-a-Thon Registration Slip may prevent NGCU from making contact to notify winners.
- Please ensure that the Sunny's Save-a-Thon Registration Slip is complete and accurate before returning it to NGCU.

#### 6. WINNER SELECTION & PRIZE REDEMPTION

- On Wednesday, May 1, 2024, NGCU will randomly select 1 winner for each branch location/county we serve.
- An NGCU staff member will contact the parent/guardian of the participant at the phone number written on the Sunny's Save-a-Thon Registration Slip to notify them of their child winning by the close of business at 5:00 PM on Wednesday, May 1, 2024.
- To receive a prize, winners must visit an NGCU location before the expiry date of Monday, May 20, 2024.
- Each winner will receive a \$50.00 cash prize.

### 7. DOCUMENTATION

- North Georgia Credit Union staff will retain all Sunny's Save-a-Thon Registration Slips for verification purposes.
- These will be kept as records and disposed of on Tuesday, May 21, 2024, after the event prize expiry date.

# 8. PUBLIC ANNOUNCEMENT

- NGCU may announce the names and, if consent is provided at the time of prize redemption, share photos of selected participants who have received their prize.
- Participants will be given the opportunity to sign a photo release form at the time of receiving their prize to grant or deny permission for the use of their name and photo for promotional purposes.
- NGCU will announce contest details on our website, social media channels, and inoffice materials within our branch locations.
