NORTH GEORGIA CREDIT UNION'S SUMMER READING PROGRAM OFFICIAL RULES

1. ELIGIBILITY

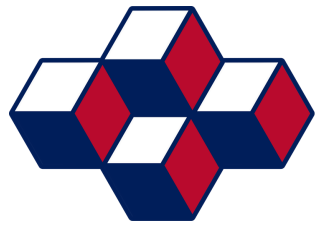
- The Savasaurus Club Summer Reading Program is free and open to all youth ages 12 and under whose parent/guardian completes and submits the Books Read Form to a North Georgia Credit Union (NGCU) location from Monday, May 20, 2024, to Friday, July 19, 2024.
- Youth do not need to be a member to participate in the Savasaurus Club Summer Reading Program.
- Definitions:
 - Youth: Any person the age of 12 or under.
 - Parent/Guardian: A legal guardian or a biological or adoptive parent who has legal responsibility for the youth participating in the contest. This includes individuals who have been granted legal guardianship or custodial rights by a court of law.

2. CONTEST PERIOD

- The contest will run from Monday, May 20, 2024, to Friday, July 19, 2024.

3. BOOKS READ FORM

- Parents/guardians must permit their child to participate by filling out the Books Read Form and returning it to an NGCU location.
- All Books Read Forms must be received before 5:00 PM Eastern Time (ET) on Friday, July 19, 2024.
- Limit one entry per person.
- The odds of winning will depend on the number of entries received and the total number of points awarded to each participant.
- This contest is void where prohibited.



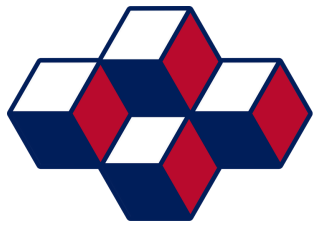

4. METHODS OF ENTRY

- Participants can visit NGCU branch locations to return their completed Books Read Form or deposit their completed form in an NGCU night depository.
- Current Savasaurus Club members of NGCU will receive a Books Read Form and information by mail.
- Regardless of the method of entry, all Books Read Forms must be received by 5:00 PM Eastern Time (ET) on Friday, July 19, 2024.
- Incomplete or inaccurate information listed on the Books Read Form may prevent NGCU from making contact to notify winners.
- Please ensure that the Books Read Form is complete and accurate before returning it.

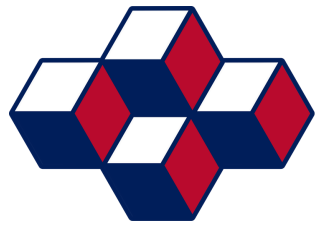

7. WINNER SELECTION & PRIZE REDEMPTION

- Participants earn 1 point for each book read during the contest period. An additional point is awarded for each book read from the Recommended Books for Financial Literacy List.
- Participants can access the Recommended Books for Financial Literacy List through the following link: <https://bit.ly/ngcubooklist2024>. Physical copies of the recommended books list will also be available at our branch locations and at the participating libraries.
- An NGCU staff member will contact the parent/guardian of the participant at the phone number provided on the Books Read Form to notify them of their child winning by the close of business at 5:00 PM on Monday, July 22, 2024.
- To receive the \$50.00 cash prize, winners must visit an NGCU location before the expiry date of Monday, August 5, 2024.

8. DOCUMENTATION

- NGCU staff will retain all Books Read Form for verification purposes.
- These will be kept as records and disposed of on Tuesday, August 6, 2024, after the event prize expiry date.
- The participant must have a library staff member initial beside each book listed on the Books Read Form when they return the book to the library to certify that the participant has read the book.

9. DISQUALIFICATION CRITERIA

- NGCU reserves the right to disqualify participants for falsification of records or failure to comply with the official rules.

10. PUBLIC ANNOUNCEMENT

- NGCU may announce the names and, if consent is provided at the time of prize redemption, share photos of selected participants who have received their prize.
- Participants will be given the opportunity to sign a photo release form at the time of receiving their prize to grant or deny permission for the use of their name and photo for promotional purposes.
